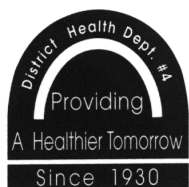

## District Health Department No. 4 COVID 19 Update

District Health Department No 4 has updated its COVID 19 Business Toolkit for local businesses and organizations who are considered essential services. The toolkit provides employers with suggested guidelines, samples of screening tools, a copy of DHD4's Emergency Executive Order 2020-1, a flowchart for potential COVID-19 exposure, and cleaning guidelines for facilities after a suspected or confirmed COVID-19 exposure (though many of these guidelines are relevant before any known exposure). We have received notification of phone scams where scammers were posing as health department employees attempting to sell COVID -19 tests or asking for personal information regarding Medicare/Medicaid. The calls appear to be originating from the health department. Anyone who receives these calls should hang up immediately. DO NOT give out any personal information. If you want to verify if the call is coming from the health department, hang up and call us directly at 1-800-221-0294.

SCAMS are on the rise. When searching for Covid-19 related information, be VERY careful. Many Covid-19 information websites are scams/fakes. Stick with the ones you know are safe and go directly to them, like...DHD4, Michigan.gov, CDC and WHO and so on. Also keep a watchful eye on your email Inbox.
