✓ If you are experiencing COVID-19 symptoms, even mild ones, please get tested. The best first step to take if you begin to feel symptoms is to contact your primary care provider. Currently, all tests in our area require a doctor's order. If you do not have a doctor or insurance, these COVID 19 testing sites will work with you and make arrangements for you to be tested. These agencies are not going to refuse testing to those that need a test based on no insurance or no provider. ✓ DHD4 wants to remind the public of possible COVID-19 exposure locations.
