## District Health Department No. 4 COVID 19 Update

✓ MDHHS has substantially expanding COVID-19 testing prioritization criteria. Newly-eligible groups include:

- Asymptomatic patients in preparation for surgical procedures, as deemed necessary by the treating clinician
- Asymptomatic people with known exposure to a person with COVID-19, or symptoms of COVID-19
- Asymptomatic people who work in a profession that puts them at high risk of exposure

Testing is also permissible for persons without symptoms who are prioritized by local health departments or clinicians, for any reason. Find your nearest testing site here:
