Potential COVID-19 Public Exposure Sites

District Health Department No. 4 (DHD4) would like to alert the public to potential COVID-19 exposure locations in our area. An individual who has tested positive has been to these locations and it is difficult for our contact tracing team to identify all of the individuals who may have been potentially exposed.

Individuals who were present at the listed locations, at the designated time, have the potential for exposure:

- The Sand Bar & Grill – 9027 W Long Lake Rd, Alpena, MI 49707
Euchre Tournament on October 22, 2020 from 3:00 p.m. – 6:00 p.m.
- Mangos Tequila Bar – 121 W Chisholm St, Alpena, MI 49707
October 24, 2020 from 5:30 p.m. – 7:30 p.m.

These individuals should monitor for symptoms consistent with COVID-19 for 14 days from exposure date. If they do not develop symptoms within 14 days of these dates, there is nothing to be done. Those that develop symptoms within 14 days of these dates should immediately quarantine themselves and contact their doctor and consider COVID-19 testing. COVID-19 symptoms include fever or chills, cough, fatigue, shortness of breath, muscle aches, sore throat, nausea, vomiting, diarrhea, and recent loss of taste or smell.

DHD4 would like to remind people that, right now, family and public gatherings are one of the major ways COVID-19 is being spread. Approximately 40% of COVID-19 cases appear to be asymptomatic. Asymptomatic cases are especially difficult because they are not sick and therefore not staying home. Individuals can spread virus prior to experiencing symptoms.

DHD4 continues to urge residents and visitors to:

- Stay Home if you are sick!
- Wear a mask in public spaces
- Maintain social distancing – at least 6 feet
- Avoiding large gatherings
- Wash your hands frequently for at least 20 seconds
