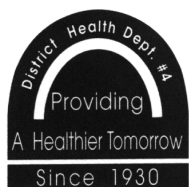

Potential COVID-19 Public Exposure Sites

District Health Department No. 4 (DHD4) would like to alert the public to potential COVID-19 exposure locations in our area. An individual who has tested positive has been to these locations and it is difficult for our contact tracing team to identify all of the individuals who may have been potentially exposed.

Individuals who were present at the listed locations, at the designated time, have the potential for exposure:

- October 28, 2020
Walmart Cheboygan from 4:00 pm – 8:30 pm
Court Yard Restaurant in Alpena from 8:00 pm – 9:00 pm
- October 29, 2020
Walmart Cheboygan from 1:00 pm – 10:00 pm
- October 30, 2020
Family Dollar Rogers City from 4:00 pm – 5:00 pm
Save a Lot Rogers City from 4:00 pm – 5:00 pm
- October 31, 2020
Up North 23 Rogers City from 5:30 pm – 7:00 pm
- November 4, 2020
Northern Lights Arena in Alpena the Hockey practice from 3:00 – 5:00 pm

These individuals should monitor for symptoms consistent with COVID-19 for 14 days from exposure date. If they do not develop symptoms within 14 days of these dates, there is nothing to be done. Those that develop symptoms within 14 days of these dates should immediately quarantine themselves and contact their doctor and consider COVID-19 testing. COVID-19 symptoms include fever or chills, cough, fatigue, shortness of breath, muscle aches, sore throat, nausea, vomiting, diarrhea, and recent loss of taste or smell.

DHD4 would like to remind people that, right now, there is community-wide COVID-19 spread. Family and public gatherings are one of the major ways COVID-19 is being spread. Please do your part:

- Stay Home if you are sick!
- Wear a mask in public and commonly used spaces
- Maintain social distancing – at least 6 feet
- Avoiding gatherings outside of your household
- Wash your hands frequently for at least 20 seconds
